4. Ada McDermit: Addressed police presence and strategies to attract qualified officers. Mayor Clark answered resident concerns admitting the Colwyn police are paid less than neighboring departments and that that often come to Colwyn Borough to get training before seeking employment with other. President Williams also stated that officers were recently provided a \$1.00 raise and admitted that a higher salary for officers would likely require an increase in taxes. Borough Manager, Iesha Nichols also addressed the residents concern about increased taxes citing deficits in sewer and trash rates that cause the Borough to subsidize each fund with general fund dollars further prohibiting the ability to give large wage increases to officers.
5. Henders Nichols: Spoke on concerns for police presence, safety, budget, recycling and trash pickup. Resident also inquired about vehicles parked on private property.
6. Matthew Faolibi: Presented concerns regarding police officers trainings, scheduling and public safety.
7. Kim Brown: Spoke on the Council's inability to dismantle the police department, officers scheduling and overtime, lack of police training and the need for a consultant to assist with police department administration of duties.
